5. PUBLICATION: ONCE APPROVED, THE ARTICLE IS PUBLISHED AND DISSEMINATED TO THE JOURNAL'S READERSHIP.

4. FINAL ACCEPTANCE: UPON SUCCESSFUL REVISION, THE MANUSCRIPT RECEIVES FINAL ACCEPTANCE FOR PUBLICATION.
5. PUBLICATION: THE ARTICLE IS THEN SCHEDULED FOR PUBLICATION, EITHER IN PRINT OR ONLINE.

IMPACT FACTOR AND INDEXING
