

LARGEST UNSOLVED BANK ROBBERY IN US HISTORY

THE LARGEST UNSOLVED BANK ROBBERY IN US HISTORY IS A TITLE THAT OFTEN CONJURES IMAGES OF DARING CRIMINALS, ELABORATE HEISTS, AND A MYSTERY THAT CAPTIVATES THE NATION. THIS PARTICULAR ROBBERY, WHICH TOOK PLACE IN 1950, REMAINS ONE OF THE MOST NOTORIOUS AND PERPLEXING CASES IN AMERICAN CRIMINAL HISTORY. THE GREAT BRINK'S ROBBERY OF 1950

ON THE MORNING OF SEPTEMBER 12, 1950, A GROUP OF ARMED ROBBERS EXECUTED AN AUDACIOUS HEIST AT THE BRINK'S ARMORED CAR DEPOT IN BOSTON, MASSACHUSETTS. WITH METICULOUS PLANNING AND A LEVEL OF SOPHISTICATION RARELY SEEN IN SUCH CRIMES, THE ROBBERS MANAGED TO STEAL AN ASTONISHING SUM OF MONEY, ESTIMATED TO BE AROUND \$1.2 MILLION—EQUIVALENT TO NEARLY \$13 MILLION TODAY WHEN ADJUSTED FOR INFLATION.

THE PLANNING AND EXECUTION

THE ROBBERY WAS ORCHESTRATED BY A GANG LED BY MASTERMIND AND CAREER CRIMINAL, ANTHONY "TONY" DEMARCO. THE GROUP WAS WELL-PREPARED, HAVING SPENT MONTHS PLANNING THE HEIST. ELEMENTS OF THEIR PLANNING INCLUDED:

- INSIDE INFORMATION: SOME OF THE GANG MEMBERS HAD PREVIOUSLY WORKED AT THE DEPOT, PROVIDING THEM INSIDER KNOWLEDGE OF THE SECURITY MEASURES AND ROUTINES.
- TIMING: THE HEIST WAS SCHEDULED FOR EARLY MORNING, TAKING ADVANTAGE OF THE LIMITED STAFF PRESENT AT THE TIME.
- DISGUISES AND WEAPONS: THE ROBBERS WERE ARMED AND WORE DISGUISES TO CONCEAL THEIR IDENTITIES, WHICH HELPED THEM EVADE IMMEDIATE RECOGNITION.

THE ROBBERY UNFOLDED AS THE GANG MEMBERS, ARMED WITH SHOTGUNS, STORMED THE DEPOT, TAKING THE EMPLOYEES HOSTAGE. THEY QUICKLY GATHERED THE CASH AND VALUABLES, LOADING THEM INTO THEIR GETAWAY VEHICLES BEFORE ESCAPING INTO THE BOSTON STREETS.

THE AFTERMATH AND INVESTIGATION

IN THE IMMEDIATE AFTERMATH OF THE ROBBERY, LAW ENFORCEMENT LAUNCHED A MASSIVE INVESTIGATION. THE FBI, ALONG WITH LOCAL POLICE, WORKED TIRELESSLY TO IDENTIFY THE PERPETRATORS AND RECOVER THE STOLEN MONEY. DESPITE THEIR EFFORTS, THE INVESTIGATION FACED SEVERAL CHALLENGES:

- LACK OF WITNESSES: MANY OF THE EMPLOYEES WERE TRAUMATIZED AND UNABLE TO PROVIDE DETAILED DESCRIPTIONS OF THE ROBBERS.
- NO PHYSICAL EVIDENCE: THE ROBBERS HAD TAKEN PRECAUTIONS TO AVOID LEAVING BEHIND FINGERPRINTS OR DNA EVIDENCE.
- PUBLIC PRESSURE: THE MEDIA FRENZY SURROUNDING THE ROBBERY CREATED IMMENSE PRESSURE ON LAW ENFORCEMENT TO DELIVER RESULTS QUICKLY.
