FOUNDATIONS OF LATOUR SCIENCE IN ACTION

THE ACTOR-NETWORK THEORY (ANT)

CENTRAL TO LATOUR'S APPROACH IS THE ACTOR-NETWORK THEORY, WHICH POSITS THAT BOTH HUMAN AND NON-HUMAN ENTITIES (SUCH AS INSTRUMENTS, TEXTS, AND TECHNOLOGIES) PARTICIPATE AS ACTORS IN NETWORKS THAT PRODUCE SCIENTIFIC KNOWLEDGE. METHODOLOGICAL APPROACHES IN LATOUR'S FRAMEWORK

TRACING THESE NETWORKS HELPS TO UNDERSTAND HOW STABILITY AND CREDIBILITY OF KNOWLEDGE CLAIMS ARE ACHIEVED.

FOCUS ON CONTROVERSY AND TRANSLATION
