KEY LAWS OF EXPONENTS COVERED IN 8TH GRADE WORKSHEETS

QUOTIENT OF POWERS RULE

IT REQUIRES SUBTRACTING THE EXPONENT IN THE DENOMINATOR FROM THE EXPONENT IN THE NUMERATOR: $a^m \div a^n = a^{m-n}$. PRACTICE PROBLEMS FREQUENTLY INVOLVE SIMPLIFYING SUCH EXPRESSIONS AND RECOGNIZING WHEN THIS LAW APPLIES.

POWER OF A POWER RULE

ACCORDING TO THIS LAW, WHEN RAISING A POWER TO ANOTHER POWER, THE EXPONENTS MULTIPLY: $(a^m)^n = a^{m \times n}$. WORKSHEETS HELP STUDENTS UNDERSTAND THIS CONCEPT BY PRESENTING NESTED EXPONENT EXPRESSIONS FOR SIMPLIFICATION.

ZERO EXPONENT RULE

COLLABORATIVE LEARNING
