THE LEADERSHIP OF ALEXANDER THE GREAT AND THE EXPANSION OF THE MACEDONIAN EMPIRE

ALEXANDER THE GREAT'S LEADERSHIP EXEMPLIFIES BOLD MILITARY STRATEGY COMBINED WITH VISIONARY AMBITION. HIS APPROACH TO CONQUEST INVOLVED RAPID, DECISIVE CAMPAIGNS THAT EXTENDED MACEDONIAN INFLUENCE ACROSS THREE CONTINENTS.
