- **QUOTATION:** (SMITH, 2010, p. 23)
- **PARAPHRASE:** (SMITH, 2010)

COMMON MISTAKES IN APA 6TH EDITION LITERATURE SAMPLES

THE CORRECT IN-TEXT CITATION FORMAT FOR A JOURNAL ARTICLE IN APA 6TH EDITION INCLUDES THE AUTHOR'S LAST NAME AND THE YEAR OF PUBLICATION, FOR EXAMPLE: (JOHNSON, 2015). FOR DIRECT QUOTES, INCLUDE THE PAGE NUMBER: (JOHNSON, 2015, p. 23).

HOW SHOULD MULTIPLE AUTHORS BE LISTED IN APA 6TH EDITION LITERATURE SAMPLES?

FOR TWO AUTHORS, LIST BOTH NAMES SEPARATED BY 'AND' IN THE REFERENCE LIST (E.G., SMITH, J., AND LEE, K.). FOR IN-TEXT CITATIONS WITH TWO AUTHORS, USE 'AND' IN NARRATIVE CITATIONS AND 'AND' IN PARENTHESES. FOR THREE TO FIVE AUTHORS, LIST ALL AUTHORS THE FIRST TIME AND USE 'ET AL.' IN SUBSEQUENT CITATIONS. FOR SIX OR MORE AUTHORS, USE 'ET AL.' FROM THE FIRST CITATION.

ARE THERE SPECIFIC GUIDELINES FOR FORMATTING THE REFERENCE LIST IN APA 6TH EDITION?

YES, THE REFERENCE LIST IN APA 6TH EDITION SHOULD BE DOUBLE-SPACED, WITH A HANGING INDENT (THE FIRST LINE OF EACH REFERENCE IS FLUSH LEFT AND SUBSEQUENT LINES ARE INDENTED). ENTRIES ARE ARRANGED ALPHABETICALLY BY THE LAST NAME OF THE FIRST AUTHOR.

HOW DO I FORMAT A LITERATURE REVIEW SAMPLE TITLE PAGE ACCORDING TO APA 6TH EDITION?
