TYPICAL DURATION OF JURY DELIBERATIONS

IN MOST CRIMINAL AND CIVIL CASES, JURY DELIBERATIONS TYPICALLY LAST FROM A FEW HOURS UP TO A COUPLE OF DAYS. SHORTER DELIBERATIONS OFTEN OCCUR IN STRAIGHTFORWARD CASES WITH CLEAR EVIDENCE, WHILE MORE COMPLEX CASES INVOLVING MULTIPLE CHARGES OR VOLUMINOUS EVIDENCE CAN EXTEND DELIBERATION TIMES. HOWEVER, EXCEPTIONALLY LONG DELIBERATIONS, SUCH AS THOSE SPANNING WEEKS, ARE RARE AND USUALLY SIGNIFY EXTRAORDINARY CIRCUMSTANCES.

LONGEST JURY DELIBERATION IN HISTORY: NOTABLE CASES

THE EXTENDED TIME WAS DUE TO THE COMPLEXITY OF THE CHARGES AND THE CONTROVERSIAL NATURE OF THE EVIDENCE PRESENTED.

OTHER REMARKABLE LONG DELIBERATIONS

ADDITIONAL CASES WITH NOTABLY LONG JURY DELIBERATIONS INCLUDE:

- THE 1989 MENENDEZ BROTHERS TRIAL, WHERE JURORS DELIBERATED FOR MORE THAN 30 HOURS OVER SEVERAL DAYS.
