- MASSACHUSETTS REAL ESTATE LAWS
- LICENSING REQUIREMENTS
- AGENCY RELATIONSHIPS IN MASSACHUSETTS

EXAM FORMAT AND SCORING

3. MANAGING TIME DURING THE EXAM

- ANSWER EASIER QUESTIONS FIRST, THEN RETURN TO MORE CHALLENGING ONES.
- USE THE "MARK" FEATURE TO FLAG QUESTIONS FOR REVIEW.
- ALLOCATE TIME TO REVIEW FLAGGED QUESTIONS AT THE END OF THE EXAM.

AFTER THE EXAM

ONCE CANDIDATES COMPLETE THE MA REAL ESTATE EXAM, THEY WILL RECEIVE THEIR SCORES IMMEDIATELY. IF SUCCESSFUL, THE NEXT STEPS INCLUDE:

1. APPLICATION FOR LICENSURE: CANDIDATES MUST SUBMIT THEIR APPLICATION FOR A REAL ESTATE LICENSE TO THE MASSACHUSETTS BOARD OF REGISTRATION OF REAL ESTATE BROKERS AND SALESPERSONS.
2. CONTINUING EDUCATION: TO MAINTAIN THEIR LICENSE, AGENTS MUST COMPLETE CONTINUING EDUCATION COURSES AS

REQUIRED BY STATE LAW.
