### NATIONALISM AND ETHNIC TENSIONS

NATIONALISM, OR STRONG PATRIOTIC FEELINGS AND DESIRE FOR INDEPENDENCE AMONG ETHNIC GROUPS, WAS ANOTHER DRIVING FORCE. IN MULTI-ETHNIC EMPIRES, NATIONALIST MOVEMENTS SOUGHT SELF-DETERMINATION, WHICH DESTABILIZED ESTABLISHED

POWERS. THIS SURGE OF NATIONALISM FOSTERED ANIMOSITY BETWEEN ETHNIC GROUPS AND NEIGHBORING COUNTRIES, FURTHER COMPLICATING DIPLOMATIC RELATIONS.

## POLITICAL AND MILITARY ALLIANCES

## SOCIAL UNREST AND NATIONAL UNITY

## FOSTERING NATIONAL PRIDE AND HATRED

PROPAGANDA CAMPAIGNS EMPHASIZED NATIONAL PRIDE AND JUSTIFIED MILITARY ACTIONS AS DEFENSIVE OR NECESSARY. THESE MESSAGES OFTEN PORTRAYED RIVAL NATIONS NEGATIVELY, INCREASING POPULAR SUPPORT FOR WAR AND REDUCING PUBLIC RESISTANCE TO CONFLICT.

## IMPACT ON CIVILIAN POPULATIONS

THE SPREAD OF PROPAGANDA INFLUENCED CIVILIAN POPULATIONS, ENCOURAGING ENLISTMENT AND SUPPORT FOR WAR EFFORTS. THIS MANIPULATION OF PUBLIC SENTIMENT HELPED SUSTAIN THE MOMENTUM TOWARD WAR AND MADE DIPLOMATIC COMPROMISES LESS ACCEPTABLE TO THE POPULACE.
