3. READ QUESTIONS CAREFULLY

DURING THE EXAM, TAKE YOUR TIME READING EACH QUESTION AND ALL ANSWER CHOICES CAREFULLY. LOOK FOR KEYWORDS THAT CAN HELP YOU IDENTIFY THE CORRECT ANSWER.

4. MANAGE YOUR TIME

KEEP AN EYE ON YOUR TIME BUT DON'T RUSH. IF YOU ENCOUNTER A DIFFICULT QUESTION, MOVE ON AND COME BACK TO IT LATER IF TIME PERMITS.
