1. MULTISTATE BAR EXAMINATION (MBE):

- THIS PORTION CONSISTS OF 200 MULTIPLE-CHOICE QUESTIONS COVERING SUBJECTS SUCH AS:
- CONTRACTS
- TORTS
- CONSTITUTIONAL LAW
- CRIMINAL LAW AND PROCEDURE
- EVIDENCE
- REAL PROPERTY
- CIVIL PROCEDURE

2. MASSACHUSETTS-SPECIFIC COMPONENTS:

- THIS INCLUDES:
- SIX ESSAYS THAT TEST KNOWLEDGE OF MASSACHUSETTS LAW.
- A PERFORMANCE TEST THAT ASSESSES PRACTICAL SKILLS IN LEGAL WRITING AND REASONING.

EXAM SCHEDULE AND ADMINISTRATION

- THE JULY BAR EXAM IS TYPICALLY HELD DURING THE LAST WEEK OF JULY.
- CANDIDATES MUST REGISTER SEVERAL MONTHS IN ADVANCE AND FULFILL ELIGIBILITY REQUIREMENTS, INCLUDING GRADUATING FROM AN ABA-ACCREDITED LAW SCHOOL.
- THE EXAM IS ADMINISTERED OVER TWO DAYS, WITH THE FIRST DAY DEDICATED TO THE ESSAY QUESTIONS AND THE PERFORMANCE TEST AND THE SECOND DAY RESERVED FOR THE MBE.

UNDERSTANDING THE RESULTS RELEASE PROCESS

THE RELEASE OF THE MASSACHUSETTS JULY BAR EXAM RESULTS IS A HIGHLY ANTICIPATED EVENT FOR CANDIDATES WHO HAVE DEDICATED SIGNIFICANT TIME AND EFFORT TO PREPARE FOR THE EXAM. THE RESULTS ARE TYPICALLY RELEASED ABOUT EIGHT WEEKS AFTER THE EXAM DATE.

TIMELINE FOR RESULTS

- EXAM DATE: LAST WEEK OF JULY
- RESULTS RELEASE: MID TO LATE SEPTEMBER
- NOTIFICATION: CANDIDATES RECEIVE THEIR RESULTS VIA EMAIL AND MAY ALSO ACCESS THEM THROUGH THE BOARD OF BAR EXAMINERS' WEBSITE.

WHAT HAPPENS AFTER THE EXAM?

- GRADING PROCESS:
- EACH COMPONENT OF THE EXAM IS GRADED SEPARATELY.
- THE ESSAYS AND PERFORMANCE TEST ARE GRADED BY EXPERIENCED ATTORNEYS, WHILE THE MBE IS SCORED USING A STANDARDIZED PROCESS.
- SCORING:
- CANDIDATES NEED A COMBINED SCORE OF 270 OUT OF A POSSIBLE 400 TO PASS.
- THE MBE ACCOUNTS FOR 50% OF THE TOTAL SCORE, WHILE THE MASSACHUSETTS COMPONENTS ACCOUNT FOR THE REMAINING 50%.

INTERPRETING THE RESULTS

RECEIVING THE RESULTS OF THE MASSACHUSETTS JULY BAR EXAM CAN ELICIT A WIDE RANGE OF EMOTIONS—FROM ANXIETY TO ELATION. CANDIDATES MUST UNDERSTAND HOW TO INTERPRET THEIR RESULTS EFFECTIVELY.

PASSING THE EXAM

- CANDIDATES WHO PASS WILL RECEIVE:
- A CONGRATULATORY LETTER FROM THE BOARD OF BAR EXAMINERS.
- INFORMATION REGARDING THE NEXT STEPS TO GAIN ADMISSION TO THE BAR, INCLUDING ATTENDING A SWEARING-IN CEREMONY.

FAILING THE EXAM

- A DETAILED BREAKDOWN OF THEIR SCORES ON EACH COMPONENT.
- INFORMATION ON REAPPLICATION FOR THE NEXT EXAM AND RESOURCES FOR PREPARATION.

THE MASSACHUSETTS BAR EXAM CONSISTS OF TWO DAYS: THE FIRST DAY INCLUDES THE MULTISTATE BAR EXAMINATION (MBE) AND THE SECOND DAY INCLUDES STATE-SPECIFIC ESSAYS AND PERFORMANCE TESTS.

CAN I APPEAL MY MASSACHUSETTS JULY BAR EXAM RESULTS?

NO, MASSACHUSETTS DOES NOT ALLOW APPEALS OF BAR EXAM RESULTS; HOWEVER, YOU CAN REQUEST A RE-EVALUATION OF YOUR ANSWERS.

WHAT ARE THE COMMON REASONS FOR FAILING THE MASSACHUSETTS BAR EXAM?

COMMON REASONS INCLUDE INADEQUATE PREPARATION, LACK OF FAMILIARITY WITH MASSACHUSETTS LAW, AND POOR TIME MANAGEMENT DURING THE EXAM.
