DESPITE ITS SUCCESS, GROWING REPORTS OF SIDE EFFECTS AND SERIOUS HEALTH INCIDENTS LED TO INCREASED SCRUTINY FROM REGULATORY AUTHORITIES AND THE PUBLIC.

MECHANISM OF ACTION OF EPHEDRA IN WEIGHT LOSS

IN 2004, AFTER REVIEWING NUMEROUS REPORTS OF ADVERSE EVENTS AND FATALITIES, THE FDA BANNED THE SALE OF EPHEDRA-CONTAINING DIETARY SUPPLEMENTS IN THE UNITED STATES. THIS DECISION WAS BASED ON EVIDENCE THAT THE RISKS OUTWEIGHED ANY POTENTIAL BENEFITS FOR WEIGHT LOSS.

IMPACT ON METABOLIFE
