Direct Proof

Proof by Contradiction

Proof by Contrapositive

Mathematical Induction

Mathematical induction is a powerful method of proof used primarily for statements involving natural numbers or sequences indexed by integers. It allows proving that a property holds for all positive integers by establishing a base case and then proving that if the property holds for an arbitrary integer k , it also holds for $k + 1$.

The Two Steps of Mathematical Induction

1. **Base Case:** Verify the statement for the initial value, usually $n = 1$ or $n = 0$.
2. **Inductive Step:** Assume the statement holds for an arbitrary integer k , and then prove it holds for $k + 1$.

Once these steps are successfully completed, the principle of mathematical induction guarantees that the statement is true for all natural numbers starting from the base case.

Example of Mathematical Induction

To prove the formula for the sum of the first n natural numbers, $1 + 2 + \dots + n = n(n + 1)/2$, induction can be used. The base case $n = 1$ is true since $1 = 1(2)/2$. Assuming the formula holds for $n = k$, adding $(k + 1)$ to both sides yields the formula for $n = k + 1$, completing the inductive step.

Proof by Exhaustion
