CRITERIA FOR IDENTIFYING EVIL INDIVIDUALS

BODIES SUCH AS THE INTERNATIONAL CRIMINAL COURT (ICC) AND AD HOC TRIBUNALS AIM TO HOLD PERPETRATORS ACCOUNTABLE, THOUGH CHALLENGES REMAIN IN ENFORCEMENT AND JURISDICTION. THESE INSTITUTIONS HELP DEFINE AND CODIFY WHAT CONSTITUTES EVIL ACTS UNDER INTERNATIONAL LAW.

NOTORIOUS WAR CRIMINALS AND DICTATORS
