HOW CAN PARENTS HELP CHILDREN COPE WITH ANXIETY RELATED TO HIGH-PROFILE CRIME CASES LIKE THE MURDAUGH MURDERS?

PARENTS CAN HELP BY REASSURING CHILDREN, PROVIDING A SAFE SPACE TO EXPRESS THEIR FEELINGS, AND LIMITING EXPOSURE TO DISTRESSING NEWS. ENGAGING IN CALMING ACTIVITIES AND FOCUSING ON POSITIVE ASPECTS OF COMMUNITY SAFETY CAN ALSO HELP.

WHAT SHOULD PARENTS CONSIDER REGARDING THE IMPACT OF MEDIA COVERAGE ON THEIR CHILDREN?

PARENTS SHOULD BE MINDFUL OF THE GRAPHIC NATURE OF SOME MEDIA COVERAGE AND ITS POTENTIAL IMPACT ON CHILDREN'S MENTAL HEALTH. IT'S CRUCIAL TO MONITOR WHAT CHILDREN CONSUME AND TO DISCUSS ANY TROUBLING CONTENT THEY ENCOUNTER.
