- SIGNATURE LINES: INCLUDE SPACES FOR BOTH PARTIES TO SIGN AND DATE THE CONTRACT, INDICATING THEIR AGREEMENT TO THE TERMS OUTLINED.

BEST PRACTICES FOR CREATING A MUSIC THERAPY CONTRACT TEMPLATE
