PHYSICAL FITNESS AND MEDICAL STANDARDS

APPLICANTS MUST MEET SPECIFIC PHYSICAL FITNESS AND MEDICAL STANDARDS. THESE INCLUDE VISION AND HEARING REQUIREMENTS, AS WELL AS THE ABILITY TO PASS A PHYSICAL FITNESS TEST. THE NATURE OF CORRECTIONAL WORK DEMANDS GOOD HEALTH AND PHYSICAL ENDURANCE TO HANDLE THE JOB'S CHALLENGES SAFELY.

EXAM CONTENT AND FORMAT
