NAVY AND MARINE CORPS AWARDS MANUAL SERVES AS THE DEFINITIVE GUIDE FOR THE PROPER ADMINISTRATION, ELIGIBILITY, AND PRESENTATION OF AWARDS WITHIN THE UNITED STATES NAVY AND MARINE CORPS. OVERVIEW OF THE NAVY AND MARINE CORPS AWARDS MANUAL

THE NAVY AND MARINE CORPS AWARDS MANUAL IS AN AUTHORITATIVE DOCUMENT THAT GOVERNS THE DISTRIBUTION AND MANAGEMENT OF MILITARY AWARDS WITHIN THESE TWO BRANCHES OF THE U.S. ARMED FORCES. IT ESTABLISHES UNIFORM STANDARDS AND PROCEDURES TO ENSURE FAIRNESS AND CONSISTENCY IN RECOGNIZING MILITARY PERSONNEL FOR THEIR CONTRIBUTIONS AND HEROISM. THE MANUAL IS REGULARLY UPDATED TO REFLECT CHANGES IN POLICY, NEW AWARDS, OR MODIFICATIONS TO EXISTING AWARDS CRITERIA. IT PROVIDES DETAILED GUIDANCE ON THE TYPES OF AWARDS AVAILABLE, THE PRECEDENCE OF DECORATIONS, AND THE RESPONSIBILITIES OF COMMANDING OFFICERS AND ADMINISTRATIVE PERSONNEL IN THE AWARDS PROCESS.

PURPOSE AND SCOPE

THE PRIMARY PURPOSE OF THE NAVY AND MARINE CORPS AWARDS MANUAL IS TO MAINTAIN A STANDARDIZED APPROACH TO RECOGNIZING OUTSTANDING PERFORMANCE AND VALOR. IT APPLIES TO ALL ACTIVE DUTY, RESERVE, AND RETIRED MEMBERS OF THE NAVY AND MARINE CORPS, ENSURING THAT AWARDS ARE GRANTED BASED ON MERIT AND IN ACCORDANCE WITH ESTABLISHED REGULATIONS. THE MANUAL ADDRESSES EVERYTHING FROM COMBAT AWARDS TO SERVICE MEDALS AND UNIT COMMENDATIONS, THEREBY COVERING THE FULL SPECTRUM OF MILITARY HONORS.

REGULATORY AUTHORITY

THIS MANUAL IS ISSUED UNDER THE AUTHORITY OF THE SECRETARY OF THE NAVY AND IS SUPPORTED BY DEPARTMENT OF DEFENSE DIRECTIVES. IT SERVES AS A SUPPLEMENT TO BROADER MILITARY AWARDS REGULATIONS AND IS CONSIDERED THE DEFINITIVE SOURCE FOR ALL MATTERS RELATED TO NAVY AND MARINE CORPS AWARDS. COMMANDERS AT ALL LEVELS ARE RESPONSIBLE FOR IMPLEMENTING THE MANUAL'S GUIDELINES AND ENSURING THAT AWARD RECOMMENDATIONS COMPLY WITH ITS PROVISIONS.

CATEGORIES OF AWARDS AND DECORATIONS

THE NAVY AND MARINE CORPS AWARDS MANUAL CATEGORIZES MILITARY AWARDS INTO SEVERAL DISTINCT TYPES, EACH SERVING A SPECIFIC PURPOSE IN RECOGNIZING DIFFERENT FORMS OF SERVICE AND ACHIEVEMENT. THESE CATEGORIES INCLUDE PERSONAL DECORATIONS, UNIT AWARDS, SERVICE MEDALS, CAMPAIGN AND EXPEDITIONARY MEDALS, AND RIBBONS. UNDERSTANDING THESE CATEGORIES IS ESSENTIAL FOR CORRECTLY IDENTIFYING THE APPROPRIATE AWARD FOR A GIVEN CIRCUMSTANCE.

PERSONAL DECORATIONS

PERSONAL DECORATIONS RECOGNIZE INDIVIDUAL ACTS OF HEROISM, MERITORIOUS SERVICE, OR OUTSTANDING ACHIEVEMENT. EXAMPLES INCLUDE THE NAVY CROSS, SILVER STAR, BRONZE STAR MEDAL, AND NAVY AND MARINE CORPS MEDAL. THESE AWARDS OFTEN REQUIRE THOROUGH JUSTIFICATION AND MUST MEET STRINGENT ELIGIBILITY STANDARDS DUE TO THEIR PRESTIGIOUS NATURE.

UNIT AWARDS

UNIT AWARDS ARE PRESENTED TO ENTIRE MILITARY UNITS FOR COLLECTIVE EXCELLENCE, HEROISM, OR OUTSTANDING PERFORMANCE. COMMON UNIT AWARDS INCLUDE THE NAVY UNIT COMMENDATION AND THE MERITORIOUS UNIT COMMENDATION. RECIPIENTS OF UNIT AWARDS ARE AUTHORIZED TO WEAR THE CORRESPONDING RIBBON OR EMBLEM AS PART OF THEIR UNIFORM.

SERVICE AND CAMPAIGN MEDALS

SERVICE MEDALS RECOGNIZE PARTICIPATION IN SPECIFIC MILITARY CAMPAIGNS OR THEATERS OF OPERATION, WHILE CAMPAIGN MEDALS DENOTE INVOLVEMENT IN CERTAIN CONFLICTS OR MISSIONS. EXAMPLES INCLUDE THE NATIONAL DEFENSE SERVICE MEDAL AND THE IRAQ CAMPAIGN MEDAL. THESE AWARDS ACKNOWLEDGE A SERVICE MEMBER'S PRESENCE DURING SIGNIFICANT MILITARY OPERATIONS.

ELIGIBILITY CRITERIA FOR AWARDS

ELIGIBILITY FOR AWARDS UNDER THE NAVY AND MARINE CORPS AWARDS MANUAL IS CAREFULLY DEFINED TO ENSURE THAT EACH DECORATION IS AWARDED APPROPRIATELY. CRITERIA VARY DEPENDING ON THE AWARD'S PURPOSE, LEVEL OF VALOR OR SERVICE RECOGNIZED, AND THE CIRCUMSTANCES SURROUNDING THE INDIVIDUAL'S ACTIONS OR SERVICE.

GENERAL ELIGIBILITY REQUIREMENTS

MOST AWARDS REQUIRE THAT THE SERVICE MEMBER DEMONSTRATE EXEMPLARY CONDUCT, OUTSTANDING ACHIEVEMENT, OR HEROISM BEYOND THE NORMAL CALL OF DUTY. THE MANUAL SPECIFIES TIMEFRAMES, DUTY ASSIGNMENTS, AND THE NATURE OF ACTIONS THAT QUALIFY FOR EACH AWARD. AWARDS MAY ALSO DEPEND ON WHETHER ACTIONS OCCURRED DURING COMBAT, PEACETIME, OR SPECIFIC OPERATIONS.

RESTRICTIONS AND LIMITATIONS

SOME AWARDS HAVE STRICT LIMITATIONS, SUCH AS RESTRICTIONS ON MULTIPLE AWARDS OR REQUIREMENTS FOR PRIOR AWARDS BEFORE ELIGIBILITY. ADDITIONALLY, AWARDS CANNOT BE GRANTED POSTHUMOUSLY UNLESS SPECIFICALLY AUTHORIZED. THE MANUAL ALSO OUTLINES DISQUALIFYING FACTORS, SUCH AS DISCIPLINARY ACTIONS OR FAILURE TO MEET CONDUCT STANDARDS, WHICH MAY PRECLUDE ELIGIBILITY.

NOMINATION AND APPROVAL PROCESS

THE PROCESS FOR NOMINATING AND APPROVING AWARDS WITHIN THE NAVY AND MARINE CORPS AWARDS MANUAL IS DESIGNED TO UPHOLD THE INTEGRITY OF MILITARY HONORS. IT INVOLVES MULTIPLE LEVELS OF REVIEW AND DOCUMENTATION TO VERIFY THE MERIT OF EACH RECOMMENDATION.

SUBMISSION OF AWARD RECOMMENDATIONS

AWARD RECOMMENDATIONS TYPICALLY ORIGINATE FROM COMMANDING OFFICERS OR SUPERVISORS FAMILIAR WITH THE NOMINEE'S PERFORMANCE. THE RECOMMENDATION MUST INCLUDE A NARRATIVE CITATION DETAILING THE ACHIEVEMENTS OR ACTIONS WARRANTING THE AWARD. SUPPORTING DOCUMENTATION, SUCH AS WITNESS STATEMENTS OR OPERATIONAL REPORTS, MAY ALSO BE REQUIRED.

CHAIN OF COMMAND REVIEW

ONCE SUBMITTED, AWARD RECOMMENDATIONS ARE REVIEWED BY SUCCESSIVE LEVELS OF COMMAND. EACH REVIEWING AUTHORITY ASSESSES THE VALIDITY OF THE NOMINATION, COMPLIANCE WITH ELIGIBILITY CRITERIA, AND THE APPROPRIATENESS OF THE AWARD LEVEL. THIS MULTI-TIERED REVIEW ENSURES THAT AWARDS ARE GRANTED BASED ON MERIT AND CONSISTENCY.

FINAL APPROVAL AND PRESENTATION

FINAL APPROVAL AUTHORITY VARIES DEPENDING ON THE AWARD'S LEVEL OF SIGNIFICANCE. HIGH-LEVEL DECORATIONS MAY REQUIRE APPROVAL FROM SENIOR COMMANDERS OR THE SECRETARY OF THE NAVY. AFTER APPROVAL, AWARDS ARE FORMALLY PRESENTED DURING CEREMONIES TO HONOR RECIPIENTS PUBLICLY AND UPHOLD THE TRADITIONS OF MILITARY RECOGNITION.

DOCUMENTATION AND RECORD KEEPING

ACCURATE DOCUMENTATION AND RECORD KEEPING ARE CRUCIAL COMPONENTS OF THE NAVY AND MARINE CORPS AWARDS MANUAL. MAINTAINING COMPREHENSIVE RECORDS ENSURES THE LEGITIMACY OF AWARDS AND SUPPORTS SERVICE MEMBERS' OFFICIAL MILITARY HISTORIES.

OFFICIAL AWARD RECORDS

ALL AWARDED DECORATIONS MUST BE RECORDED IN THE SERVICE MEMBER'S OFFICIAL MILITARY PERSONNEL FILE. THIS DOCUMENTATION INCLUDES THE AWARD CITATION, APPROVAL ORDERS, AND ANY SUPPORTING MATERIALS. THESE RECORDS ARE ESSENTIAL FOR VERIFYING ELIGIBILITY FOR BENEFITS AND FUTURE PROMOTIONS.

MAINTENANCE OF AWARD DATABASES

THE NAVY AND MARINE CORPS MAINTAIN CENTRALIZED DATABASES TRACKING AWARDS AND DECORATIONS. THESE SYSTEMS FACILITATE EFFICIENT MANAGEMENT OF AWARDS, PREVENT DUPLICATION, AND PROVIDE ACCESSIBLE RECORDS FOR PERSONNEL AND ADMINISTRATIVE USE. PROPER RECORD MAINTENANCE ALSO AIDS IN HISTORICAL RESEARCH AND VETERAN AFFAIRS.

SIGNIFICANCE OF THE AWARDS MANUAL IN MILITARY CULTURE

AWARD APPROVAL AUTHORITY VARIES DEPENDING ON THE TYPE OF AWARD BUT GENERALLY INCLUDES COMMANDING OFFICERS, COMMANDING OFFICERS' REPRESENTATIVES, AND HIGHER ECHELON AUTHORITIES AS SPECIFIED IN THE MANUAL.

HOW DOES THE NAVY AND MARINE CORPS AWARDS MANUAL DEFINE ELIGIBILITY

CRITERIA FOR MEDALS?
