## ANNUAL EXAM SCHEDULE

THE CONSISTENCY IN SCHEDULING HELPS CANDIDATES ANTICIPATE THE TIMEFRAME FOR APPLICATION SUBMISSIONS, STUDY PERIODS, AND RESULT RELEASES. BELOW IS A TYPICAL PATTERN FOR THE EXAM MONTHS:

- FEBRUARY EXAM: LAST TUESDAY AND WEDNESDAY OF FEBRUARY
- JULY EXAM: LAST TUESDAY AND WEDNESDAY OF JULY

## RESULT RELEASE TIMELINE

RESULTS FOR THE NC BAR EXAM ARE USUALLY RELEASED WITHIN 8 TO 10 WEEKS AFTER THE EXAM DATES. THIS TIMELINE PROVIDES CANDIDATES WITH AN EXPECTED DATE FOR OUTCOME NOTIFICATION, WHICH IS CRUCIAL FOR PLANNING THE NEXT STEPS IN THEIR LEGAL CAREERS. THE BOARD OF LAW EXAMINERS SENDS OFFICIAL SCORE NOTICES VIA MAIL TO ALL CANDIDATES. # APPLICATION AND REGISTRATION DEADLINES

## REQUIRED DOCUMENTS AND FEES

ALONG WITH THE APPLICATION, CANDIDATES MUST SUBMIT VARIOUS DOCUMENTS, INCLUDING PROOF OF GRADUATION FROM AN ABA-ACCREDITED LAW SCHOOL, CHARACTER AND FITNESS DISCLOSURES, AND PAYMENT OF THE EXAMINATION FEE. IT IS ESSENTIAL TO REVIEW THE APPLICATION CHECKLIST CAREFULLY AND ENSURE ALL MATERIALS ARE COMPLETE TO AVOID DELAYS OR DISQUALIFICATION. THE EXAM FEE MUST BE PAID BY THE POSTED DEADLINE TO SECURE A TESTING SPOT.

## EXAM FORMAT AND SCHEDULE

THE NC BAR EXAM FOLLOWS THE UNIFORM BAR EXAMINATION (UBE) FORMAT, WHICH INCLUDES MULTIPLE COMPONENTS ADMINISTERED OVER TWO DAYS. UNDERSTANDING THE STRUCTURE AND TIMING OF THE EXAM IS ESSENTIAL FOR EFFECTIVE PREPARATION AND TIME MANAGEMENT.

CANDIDATES SHOULD BE PREPARED TO DEMONSTRATE BOTH ANALYTICAL AND PRACTICAL SKILLS DURING THIS DAY.

### DAY 2: MULTISTATE BAR EXAMINATION (MBE)

THE SECOND DAY IS DEDICATED TO THE MULTISTATE BAR EXAMINATION, A MULTIPLE-CHOICE TEST COMPRISING 200

QUESTIONS. THE MBE COVERS CORE LEGAL SUBJECTS SUCH AS CONSTITUTIONAL LAW, CONTRACTS, CRIMINAL LAW, EVIDENCE, REAL PROPERTY, AND TORTS. THIS SECTION ASSESSES CANDIDATES' ABILITY TO APPLY FUNDAMENTAL LEGAL PRINCIPLES IN A TIMED SETTING.

- **DAY 1 MORNING:** MULTISTATE PERFORMANCE TEST (MPT)
- **DAY 1 AFTERNOON:** MULTISTATE ESSAY EXAM (MEE)
- **DAY 2:** MULTISTATE BAR EXAMINATION (MBE)

## IMPORTANT CONSIDERATIONS AND UPDATES
