IT IS A MANDATORY ASSESSMENT FOR ALL TEENAGERS AND NEW DRIVERS WHO WISH TO OBTAIN THEIR LEARNER'S PERMIT OR PROVISIONAL LICENSE. THE EXAM ENSURES THAT STUDENTS UNDERSTAND ESSENTIAL DRIVING CONCEPTS, TRAFFIC LAWS, AND SAFE DRIVING PRACTICES TAILORED TO THE STATE'S UNIQUE ROAD CONDITIONS AND REGULATIONS. PASSING THIS EXAM IS ONE OF THE LAST STEPS BEFORE GAINING FULL DRIVING PRIVILEGES, MAKING IT A KEY MILESTONE IN THE LICENSING PROCESS.

PURPOSE OF THE EXAM

VEHICLE OPERATION AND MAINTENANCE

BASIC KNOWLEDGE OF VEHICLE CONTROLS, DASHBOARD INDICATORS, AND ROUTINE MAINTENANCE TASKS MAY BE COVERED TO ENSURE DRIVERS CAN OPERATE A VEHICLE SAFELY AND RECOGNIZE POTENTIAL MECHANICAL ISSUES.

SEAT BELT AND CHILD SAFETY LAWS

NORTH CAROLINA LAW MANDATES SEAT BELT USE FOR ALL OCCUPANTS AND REQUIRES CHILDREN UNDER CERTAIN AGES AND SIZES TO BE SECURED IN APPROPRIATE CHILD SAFETY SEATS. THESE LAWS ARE STRICTLY ENFORCED AND COVERED ON THE EXAM.

REGULATIONS IS TESTED ON THE EXAM.
