ELIGIBILITY REQUIREMENTS

1. AGE: APPLICANTS MUST BE AT LEAST 18 YEARS OLD.

THE NEVADA REAL ESTATE LICENSE EXAM CONSISTS OF 120 QUESTIONS IN TOTAL: 80 QUESTIONS ON NATIONAL TOPICS AND 40 QUESTIONS SPECIFIC TO NEVADA REAL ESTATE PRACTICES.

What Is the Passing Score for the Nevada Real Estate License Exam?

YOU MUST SCORE AT LEAST 75% TO PASS THE NEVADA REAL ESTATE LICENSE EXAM, WHICH MEANS YOU NEED TO ANSWER AT LEAST 90 QUESTIONS CORRECTLY OUT OF THE 120 TOTAL.

How Often Is the Nevada Real Estate License Exam Offered?
