THIS LICENSE IS ESSENTIAL FOR ANYONE ASPIRING TO WORK IN THE INSURANCE SECTOR, AS IT ENSURES THAT AGENTS HAVE A THOROUGH UNDERSTANDING OF THE LEGAL AND FINANCIAL ASPECTS OF INSURANCE.

EXAM REQUIREMENTS

- CANDIDATES ARE REQUIRED TO COMPLETE A PRE-LICENSING EDUCATION COURSE CONSISTING OF 75 HOURS OF INSTRUCTION. THIS COURSE CAN BE TAKEN IN PERSON OR ONLINE AND MUST COVER SPECIFIC TOPICS MANDATED BY THE STATE.

EXAM OVERVIEW

THE NEW YORK STATE PROPERTY AND CASUALTY LICENSE EXAM IS DESIGNED TO ASSESS A CANDIDATE'S KNOWLEDGE OF VARIOUS INSURANCE CONCEPTS AND REGULATIONS. THE EXAM CONSISTS OF:

- QUESTIONS: 150 MULTIPLE-CHOICE QUESTIONS
- TIME LIMIT: 150 MINUTES
- PASSING SCORE: 70% (105 CORRECT ANSWERS NEEDED)

EXAM FORMAT

THE EXAM IS ADMINISTERED IN A COMPUTER-BASED FORMAT AT DESIGNATED TESTING CENTERS THROUGHOUT NEW YORK. CANDIDATES WILL RECEIVE THEIR SCORES IMMEDIATELY UPON COMPLETION OF THE EXAM, ALLOWING THEM TO KNOW IF THEY HAVE PASSED OR NEED TO RETAKE IT.

- IF UNSURE ABOUT A QUESTION, MARK IT FOR REVIEW AND COME BACK IF TIME PERMITS.

4. AFTER THE EXAM

- UPON COMPLETION, YOU WILL RECEIVE YOUR SCORE IMMEDIATELY.
- IF YOU PASS, YOU WILL RECEIVE INSTRUCTIONS ON THE NEXT STEPS FOR OBTAINING YOUR LICENSE.
- IF YOU DO NOT PASS, REVIEW YOUR SCORE REPORT TO UNDERSTAND AREAS OF WEAKNESS AND SCHEDULE A RETAKE.

THE EXAM FEE IS TYPICALLY AROUND \$40, BUT IT MAY VARY DEPENDING ON THE EXAM PROVIDER.

HOW OFTEN CAN I RETAKE THE NEW YORK STATE PROPERTY AND CASUALTY LICENSE EXAM IF I FAIL?

IF YOU FAIL THE EXAM, YOU CAN RETAKE IT AFTER A WAITING PERIOD OF 30 DAYS.
