EXAM STRUCTURE

- **STRENGTH TRAINING:** INCORPORATE WEIGHT TRAINING TO BUILD STRENGTH, WHICH IS VITAL FOR VARIOUS LAW ENFORCEMENT SCENARIOS.
- **FLEXIBILITY AND AGILITY:** INCLUDE EXERCISES THAT ENHANCE FLEXIBILITY AND AGILITY, SUCH AS YOGA OR MARTIAL ARTS.

POST-EXAM PROCESS

INTERVIEW PROCESS

3. **PHYSICAL FITNESS ASSESSMENT:** A PHYSICAL AGILITY TEST MAY ALSO BE ADMINISTERED TO ASSESS THE CANDIDATE'S FITNESS LEVELS.

BACKGROUND INVESTIGATION

A THOROUGH BACKGROUND INVESTIGATION IS CONDUCTED FOR CANDIDATES WHO PROGRESS BEYOND THE INTERVIEW STAGE. THIS INVESTIGATION TYPICALLY INCLUDES:

- **CRIMINAL HISTORY CHECK:** REVIEW OF ANY PREVIOUS ARRESTS OR CONVICTIONS.

- **PERSONAL INTERVIEWS:** INTERVIEWS WITH ACQUAINTANCES, FAMILY MEMBERS, AND FORMER EMPLOYERS.

WHAT ARE THE AGE REQUIREMENTS FOR TAKING THE NJ CIVIL SERVICE POLICE EXAM?

CANDIDATES MUST BE AT LEAST 18 YEARS OLD TO TAKE THE NJ CIVIL SERVICE POLICE EXAM, AND THEY TYPICALLY NEED TO BE UNDER 35 YEARS OLD AT THE TIME OF APPOINTMENT TO A POLICE POSITION.
