UNDERSTANDING THE NOTARY SIGNING AGENT ROLE

UNDERSTANDING THE RESPONSIBILITIES AND LEGAL OBLIGATIONS OF THIS POSITION IS FUNDAMENTAL FOR EXAM PREPARATION AND PRACTICAL APPLICATION.

KEY RESPONSIBILITIES

NOTARY SIGNING AGENTS ARE ENTRUSTED WITH VERIFYING THE IDENTITY OF SIGNERS, WITNESSING SIGNATURES, AND AFFIXING OFFICIAL NOTARY SEALS ON LOAN DOCUMENTS.
