NOTARY COMMISSION REQUIREMENT

SINCE A NOTARY SIGNING AGENT MUST BE A COMMISSIONED NOTARY PUBLIC, APPLICANTS MUST APPLY FOR AND RECEIVE A PENNSYLVANIA NOTARY COMMISSION. THIS INVOLVES SUBMITTING AN APPLICATION TO THE PENNSYLVANIA DEPARTMENT OF STATE, PAYING THE APPLICABLE FEES, AND PASSING ANY REQUIRED BACKGROUND CHECKS. OBTAINING THE COMMISSION IS A MANDATORY STEP BEFORE UNDERTAKING NOTARY SIGNING AGENT TRAINING OR NOTARIZING DOCUMENTS.

CORE COMPONENTS OF NOTARY SIGNING AGENT TRAINING

REGISTERING WITH SIGNING SERVICES

AFTER CERTIFICATION, AGENTS TYPICALLY REGISTER WITH SIGNING SERVICES AND TITLE COMPANIES THAT COORDINATE LOAN SIGNINGS. BEING LISTED ON THESE PLATFORMS INCREASES AN AGENT'S VISIBILITY AND JOB PROSPECTS. REGISTRATION OFTEN REQUIRES PROOF OF COMMISSION, CERTIFICATION, BACKGROUND CHECKS, AND ERRORS AND OMISSIONS INSURANCE.

ERRORS AND OMISSIONS INSURANCE

MANY NOTARY SIGNING AGENTS OBTAIN ERRORS AND OMISSIONS (E&O) INSURANCE TO PROTECT THEMSELVES FROM POTENTIAL LEGAL CLAIMS ARISING FROM MISTAKES OR NEGLIGENCE DURING THE SIGNING PROCESS. SOME TRAINING PROGRAMS INCLUDE GUIDANCE ON SECURING APPROPRIATE INSURANCE COVERAGE.

WHILE PENNSYLVANIA DOES NOT MANDATE CONTINUING EDUCATION FOR NOTARIES, MANY SIGNING AGENTS PURSUE ADDITIONAL TRAINING TO STAY CURRENT WITH INDUSTRY CHANGES, NEW REGULATIONS, AND BEST PRACTICES. THIS ONGOING LEARNING ENHANCES SKILLS AND MAINTAINS COMPETITIVE ADVANTAGE.
