FORMAT OF THE OET WRITING SUB-TEST

TYPES OF LETTERS

THE IMPORTANCE OF OET WRITING PRACTICE

PREPARATION TIPS FOR OET WRITING

2. INTRODUCTION: BRIEFLY INTRODUCE THE PATIENT AND THE PURPOSE OF THE LETTER.
3. BODY: PROVIDE DETAILED INFORMATION, ORGANIZED INTO CLEAR PARAGRAPHS. INCLUDE:
 - PATIENT'S MEDICAL HISTORY
 - CURRENT CONDITION
 - RELEVANT TEST RESULTS
 - ANY TREATMENTS ADMINISTERED
 - RECOMMENDATIONS OR ACTIONS NEEDED
4. CONCLUSION: SUMMARIZE THE KEY POINTS AND EXPRESS WILLINGNESS TO PROVIDE FURTHER INFORMATION IF REQUIRED.
5. CLOSING: SIGN OFF APPROPRIATELY (E.G., "YOURS SINCERELY," FOLLOWED BY YOUR NAME AND TITLE).

USE CLEAR AND CONCISE LANGUAGE

- AVOID AMBIGUITY: USE PRECISE LANGUAGE TO MINIMIZE MISUNDERSTANDINGS.
- LIMIT JARGON: WHILE MEDICAL TERMINOLOGY MAY BE NECESSARY, ENSURE THAT IT IS RELEVANT TO THE RECIPIENT'S UNDERSTANDING.
- SHORT SENTENCES: AIM FOR CLARITY BY USING SHORTER SENTENCES THAT CONVEY YOUR MESSAGE EFFECTIVELY.

EDIT AND PROOFREAD

AFTER WRITING YOUR LETTER, TAKE THE TIME TO:

- REVIEW CONTENT: ENSURE ALL NECESSARY INFORMATION IS INCLUDED AND RELEVANT.
- CHECK GRAMMAR AND SPELLING: LOOK FOR COMMON GRAMMATICAL ERRORS AND CORRECT SPELLING MISTAKES.
- SEEK PEER REVIEW: IF POSSIBLE, HAVE A COLLEAGUE REVIEW YOUR LETTER FOR ADDITIONAL FEEDBACK.

PRACTICE ACTIVITIES FOR OET WRITING

ENGAGING IN SPECIFIC PRACTICE ACTIVITIES CAN GREATLY IMPROVE YOUR WRITING SKILLS FOR THE OET. HERE ARE SOME EFFECTIVE EXERCISES:

SAMPLE WRITING PROMPTS

MOCK TESTS

- TAKE FULL-LENGTH PRACTICE TESTS THAT INCLUDE THE WRITING SUB-TEST TO BUILD ENDURANCE AND FAMILIARITY WITH THE EXAM FORMAT.

- REVIEW YOUR RESULTS AND ANALYZE YOUR PERFORMANCE TO IDENTIFY PATTERNS IN YOUR MISTAKES.
