PURPOSE OF THE OHIO CHILD SUPPORT CALCULATION WORKSHEET

STEP-BY-STEP PROCESS FOR COMPLETING THE WORKSHEET

6. **DETERMINE THE FINAL CHILD SUPPORT AMOUNT:** AFTER MAKING ALL ADJUSTMENTS AND CONSIDERING ADDITIONAL EXPENSES, DETERMINE THE FINAL CHILD SUPPORT AMOUNT THAT ONE PARENT WILL PAY TO THE OTHER.
7. **REVIEW AND SUBMIT:** REVIEW THE COMPLETED WORKSHEET FOR ACCURACY, AND SUBMIT IT AS REQUIRED BY THE COURT.

FACTORS INFLUENCING CHILD SUPPORT CALCULATIONS

SEVERAL FACTORS CAN INFLUENCE THE OUTCOME OF CHILD SUPPORT CALCULATIONS IN OHIO, INCLUDING:

- **INCOME LEVELS:** THE TOTAL INCOME OF BOTH PARENTS IS THE MOST SIGNIFICANT FACTOR IN DETERMINING CHILD SUPPORT OBLIGATIONS.

COMMON MISCONCEPTIONS ABOUT CHILD SUPPORT IN OHIO

2. **CHILD SUPPORT COVERS ALL EXPENSES:** SOME PARENTS THINK THAT CHILD SUPPORT COVERS ALL EXPENSES RELATED TO THE CHILD. HOWEVER, IT TYPICALLY COVERS BASIC NEEDS LIKE FOOD, CLOTHING, AND SHELTER, WHILE ADDITIONAL EXPENSES MAY NEED TO BE NEGOTIATED SEPARATELY.
3. **CHILD SUPPORT ENDS AT AGE 18:** WHILE CHILD SUPPORT TYPICALLY ENDS WHEN A CHILD TURNS 18, IT CAN CONTINUE LONGER IF THE CHILD IS STILL IN HIGH SCHOOL OR HAS SPECIAL NEEDS.

IS THE OHIO CHILD SUPPORT CALCULATION WORKSHEET THE SAME FOR ALL COUNTIES IN OHIO?

YES, THE OHIO CHILD SUPPORT CALCULATION WORKSHEET FOLLOWS THE SAME STATE GUIDELINES; HOWEVER, SPECIFIC LOCAL RULES OR PRACTICES MAY VARY SLIGHTLY BY COUNTY.
