1. PARENT INFORMATION

2. INCOME CALCULATION

5. ADDITIONAL EXPENSES

THIS SECTION ALLOWS FOR THE INCLUSION OF ADDITIONAL EXPENSES THAT MAY BE NECESSARY FOR THE CHILD'S WELL-BEING, SUCH AS:

- CHILD CARE COSTS
- MEDICAL EXPENSES
- EDUCATIONAL EXPENSES (TUITION, SUPPLIES)

USING THE OHIO CHILD SUPPORT WORKSHEET

COMPLETING THE OHIO CHILD SUPPORT WORKSHEET REQUIRES CAREFUL ATTENTION TO DETAIL AND AN UNDERSTANDING OF THE SPECIFIC GUIDELINES LAID OUT BY THE STATE. HERE ARE THE STEPS TO FOLLOW:
