5. **PASS THE OHIO REAL ESTATE LICENSE EXAM:** THIS IS THE FINAL HURDLE BEFORE OBTAINING YOUR LICENSE.
6. **CHOOSE A BROKER:** FINALLY, CANDIDATES MUST FIND A LICENSED BROKER TO WORK UNDER AS A REAL ESTATE AGENT.

COMPONENTS OF THE OHIO REAL ESTATE LICENSE EXAM

THE OHIO REAL ESTATE LICENSE EXAM IS DIVIDED INTO TWO MAIN SECTIONS: THE NATIONAL PORTION AND THE STATE-SPECIFIC PORTION. EACH SECTION TESTS DIFFERENT ASPECTS OF REAL ESTATE KNOWLEDGE.

1. NATIONAL PORTION

THE NATIONAL PORTION COVERS GENERAL REAL ESTATE CONCEPTS AND PRINCIPLES THAT ARE APPLICABLE ACROSS THE UNITED STATES. TOPICS INCLUDE:

- REAL ESTATE OWNERSHIP
- PROPERTY VALUATION AND APPRAISAL
- REAL ESTATE CONTRACTS

- FINANCING AND MORTGAGES
- REAL ESTATE AGENCY
- FAIR HOUSING LAWS

THIS SECTION TYPICALLY CONSISTS OF MULTIPLE-CHOICE QUESTIONS AND ACCOUNTS FOR A SIGNIFICANT PORTION OF THE OVERALL EXAM.

2. STATE-SPECIFIC PORTION

THE STATE-SPECIFIC PORTION FOCUSES ON REAL ESTATE LAWS AND PRACTICES THAT ARE UNIQUE TO OHIO. KEY AREAS OF KNOWLEDGE INCLUDE:

- OHIO REAL ESTATE LAW
- REAL ESTATE AGENCY RELATIONSHIPS
- CLOSING AND SETTLEMENT PROCEDURES
- OHIO FAIR HOUSING LAWS

THIS SECTION ALSO CONSISTS OF MULTIPLE-CHOICE QUESTIONS AND IS ESSENTIAL FOR UNDERSTANDING HOW REAL ESTATE OPERATES WITHIN THE STATE.

EXAM FORMAT AND DURATION

THE OHIO REAL ESTATE LICENSE EXAM IS COMPUTER-BASED AND IS ADMINISTERED AT VARIOUS PEARSON VUE TESTING CENTERS THROUGHOUT THE STATE. HERE ARE SOME KEY DETAILS ABOUT THE EXAM FORMAT:

- TOTAL QUESTIONS: THE EXAM CONSISTS OF 120 QUESTIONS (80 NATIONAL AND 40 STATE-SPECIFIC).

2. CREATE A STUDY SCHEDULE

ESTABLISHING A STRUCTURED STUDY SCHEDULE CAN HELP YOU STAY ORGANIZED AND ENSURE YOU COVER ALL NECESSARY MATERIALS. CONSIDER THE FOLLOWING:

- ALLOCATE SPECIFIC TIME SLOTS EACH WEEK FOR STUDYING
- BREAK DOWN TOPICS INTO MANAGEABLE SECTIONS
- REVIEW REGULARLY TO REINFORCE YOUR KNOWLEDGE

3. UTILIZE PRACTICE EXAMS

TAKING PRACTICE EXAMS IS ONE OF THE MOST EFFECTIVE WAYS TO PREPARE. THEY CAN HELP YOU:

- FAMILIARIZE YOURSELF WITH THE EXAM FORMAT
- IDENTIFY AREAS WHERE YOU NEED TO IMPROVE
- BUILD CONFIDENCE BEFORE THE ACTUAL EXAM

4. JOIN STUDY GROUPS

COLLABORATING WITH FELLOW CANDIDATES CAN ENHANCE YOUR UNDERSTANDING OF COMPLEX TOPICS. CONSIDER FORMING A STUDY GROUP TO:

- DISCUSS CHALLENGING CONCEPTS
- SHARE RESOURCES AND STUDY MATERIALS
- PROVIDE MUTUAL SUPPORT AND MOTIVATION

5. REVIEW OHIO REAL ESTATE LAWS

GIVEN THAT THE STATE-SPECIFIC PORTION FOCUSES HEAVILY ON OHIO LAWS, MAKE SURE TO SPEND AMPLE TIME REVIEWING:

- THE OHIO REVISED CODE RELATED TO REAL ESTATE
- THE OHIO ADMINISTRATIVE CODE
- IMPORTANT REGULATIONS AND GUIDELINES

WHAT TO EXPECT ON EXAM DAY

ON THE DAY OF YOUR OHIO REAL ESTATE LICENSE EXAM, IT'S ESSENTIAL TO BE PREPARED AND KNOW WHAT TO EXPECT. HERE ARE SOME KEY POINTERS:

EXAM NERVES ARE NATURAL, BUT STAYING CALM CAN HELP YOU PERFORM BETTER. TAKE DEEP BREATHS AND REMIND YOURSELF THAT YOU HAVE PREPARED WELL.

AFTER THE EXAM: NEXT STEPS

ONCE YOU HAVE COMPLETED THE OHIO REAL ESTATE LICENSE EXAM, YOU WILL RECEIVE YOUR RESULTS IMMEDIATELY. IF YOU PASS, YOU WILL RECEIVE INSTRUCTIONS ON HOW TO PROCEED WITH OBTAINING YOUR LICENSE. IF YOU DO NOT PASS, YOU MAY RETAKE THE EXAM AFTER A WAITING PERIOD, SO DON'T BE DISCOURAGED.

FREQUENTLY ASKED QUESTIONS

WHAT ARE THE ELIGIBILITY REQUIREMENTS TO TAKE THE OHIO REAL ESTATE LICENSE EXAM?

TO BE ELIGIBLE FOR THE OHIO REAL ESTATE LICENSE EXAM, YOU MUST BE AT LEAST 18 YEARS OLD, HAVE A HIGH SCHOOL DIPLOMA OR EQUIVALENT, AND COMPLETE 120 HOURS OF PRE-LICENSING EDUCATION FROM AN APPROVED PROVIDER.

HOW MUCH DOES IT COST TO TAKE THE OHIO REAL ESTATE LICENSE EXAM?

AS OF NOW, THE FEE FOR THE OHIO REAL ESTATE LICENSE EXAM IS APPROXIMATELY \$65, BUT THIS CAN VARY, SO IT'S ADVISABLE TO CHECK WITH THE TESTING PROVIDER FOR THE MOST CURRENT FEES.

WHAT TOPICS ARE COVERED ON THE OHIO REAL ESTATE LICENSE EXAM?

THE OHIO REAL ESTATE LICENSE EXAM COVERS VARIOUS TOPICS, INCLUDING REAL ESTATE PRINCIPLES, PRACTICES, LAWS, FINANCE, AND PROPERTY MANAGEMENT, AS WELL AS OHIO-SPECIFIC REGULATIONS.

AFTER PASSING THE OHIO REAL ESTATE LICENSE EXAM, YOU NEED TO APPLY FOR YOUR REAL ESTATE LICENSE WITH THE OHIO DIVISION OF REAL ESTATE AND PROFESSIONAL LICENSING, WHICH INCLUDES SUBMITTING YOUR EXAM RESULTS AND PAYING THE LICENSING FEE.
