- **REACTIVE MATERIALS:** SUBSTANCES THAT CAN UNDERGO A CHEMICAL CHANGE, RELEASING ENERGY IN THE FORM OF AN EXPLOSION OR TOXIC GAS.

UNDERSTANDING THESE CLASSIFICATIONS IS CRUCIAL FOR ANYONE WORKING WITH OR AROUND HAZARDOUS MATERIALS.

## OKLAHOMA REGULATIONS AND STANDARDS

IN OKLAHOMA, HAZMAT REGULATIONS ARE PRIMARILY GOVERNED BY THE OKLAHOMA DEPARTMENT OF ENVIRONMENTAL QUALITY (ODEQ) AND FEDERAL GUIDELINES SET BY THE ENVIRONMENTAL PROTECTION AGENCY (EPA) AND THE OCCUPATIONAL SAFETY AND HEALTH ADMINISTRATION (OSHA). FAMILIARITY WITH THESE REGULATIONS IS ESSENTIAL FOR COMPLIANCE AND SAFETY.
