UNDERSTANDING OREGON BOATERS LICENSE REQUIREMENTS

TO LEGALLY OPERATE A MOTORIZED BOAT IN OREGON, INDIVIDUALS MUST MEET SPECIFIC LICENSING REQUIREMENTS ESTABLISHED BY THE OREGON STATE MARINE BOARD.
