## OVERVIEW OF OREGON COSMETOLOGY LAWS AND RULES

THE COSMETOLOGY PROFESSION IN OREGON IS REGULATED BY THE OREGON HEALTH LICENSING OFFICE (OHLO), WHICH ESTABLISHES LAWS AND RULES TO ENSURE PUBLIC SAFETY AND PROFESSIONAL COMPETENCY. THESE REGULATIONS ARE CODIFIED IN THE OREGON ADMINISTRATIVE RULES (OAR) AND THE OREGON REVISED STATUTES (ORS). THE LAWS DEFINE LICENSING REQUIREMENTS, PERMISSIBLE SERVICES, OPERATIONAL STANDARDS FOR SALONS, AND THE DISCIPLINARY PROCESS FOR VIOLATIONS. A THOROUGH UNDERSTANDING OF THESE LAWS AND RULES IS MANDATORY FOR COSMETOLOGISTS TO LEGALLY PRACTICE WITHIN THE STATE AND MAINTAIN ETHICAL STANDARDS. ## REGULATORY AUTHORITY AND ENFORCEMENT

## LICENSING REQUIREMENTS FOR COSMETOLOGISTS IN OREGON

- USE OF ELECTRICAL AND MECHANICAL BEAUTY DEVICES

## PROFESSIONAL CONDUCT AND ETHICS

PRACTITIONERS MUST MAINTAIN PROFESSIONALISM, RESPECT CLIENT CONFIDENTIALITY, AND PROVIDE SERVICES IN A SAFE AND HYGIENIC MANNER. VIOLATIONS OF ETHICAL STANDARDS CAN LEAD TO DISCIPLINARY ACTIONS UNDER OREGON LAW.

## HEALTH, SAFETY, AND SANITATION REGULATIONS

PUBLIC HEALTH AND SAFETY ARE PARAMOUNT IN OREGON COSMETOLOGY LAWS. THE REGULATIONS SET STRICT STANDARDS FOR SANITATION, EQUIPMENT STERILIZATION, AND SALON CLEANLINESS TO PREVENT THE SPREAD OF INFECTIONS AND ENSURE CLIENT SAFETY.

## SANITATION REQUIREMENTS
