OF LICENSING. SPECIFIC REQUIREMENTS DEPEND ON THE BUSINESS STRUCTURE AND INDUSTRY. EVEN HOME-BASED BUSINESSES OFTEN NEED LOCAL PERMITS OR REGISTRATIONS. FAILURE TO OBTAIN THE NECESSARY LICENSES CAN LEAD TO FINES, LEGAL ACTION, OR BUSINESS CLOSURE.

How to Conduct an Oregon State Business License Search

OREGON SECRETARY OF STATE BUSINESS REGISTRY
