THESE QUESTIONS PRESENT A HYPOTHETICAL SITUATION AND ASK YOU TO APPLY YOUR KNOWLEDGE TO DETERMINE THE CORRECT COURSE OF ACTION. FOR EXAMPLE:

A REAL ESTATE AGENT DISCOVERS THAT A PROPERTY THEY ARE LISTING HAS SIGNIFICANT STRUCTURAL DAMAGE. WHAT IS THE AGENT'S ETHICAL OBLIGATION?

- A) TO HIDE THE DAMAGE TO CLOSE THE SALE
- B) TO DISCLOSE THE DAMAGE TO POTENTIAL BUYERS
- C) TO INFORM THE SELLER BUT NOT THE BUYERS
- D) TO IGNORE THE DAMAGE IF IT IS NOT VISIBLE
