PASSING SCORE FOR MFT CLINICAL EXAM

THE PASSING SCORE FOR MFT CLINICAL EXAM VARIES DEPENDING ON THE ADMINISTERING ORGANIZATION AND JURISDICTION, BUT

IT GENERALLY REFLECTS A LEVEL OF PROFICIENCY INDICATIVE OF SAFE AND EFFECTIVE CLINICAL PRACTICE. MOST STATES OR CERTIFYING BODIES SET THE PASSING SCORE AS A SCALED SCORE RATHER THAN A RAW PERCENTAGE TO ACCOUNT FOR EXAM DIFFICULTY VARIATIONS. SCALED SCORES VS. RAW SCORES

MINIMUM REQUIREMENTS

PARTIAL CREDIT MAY BE AWARDED FOR RESPONSES DEMONSTRATING PARTIAL KNOWLEDGE OR APPROPRIATE CLINICAL JUDGMENT. THE TOTAL SCORE AGGREGATES POINTS FROM ALL ITEMS, WHICH IS THEN CONVERTED TO A SCALED SCORE USED TO DETERMINE PASS OR FAIL STATUS.

PREPARATION STRATEGIES TO ACHIEVE PASSING SCORE

RETAKE POLICIES AND SCORE IMPROVEMENT

RETAKE PROCEDURES
