- **JARGON:** SPECIALIZED LANGUAGE THAT CAN ALIENATE THOSE NOT IN THE KNOW, MAKING IT DIFFICULT FOR THE PUBLIC TO ENGAGE IN POLITICAL DISCOURSE.
- **CLICHE**  **OVERUSED PHRASES THAT LACK ORIGINALITY AND CRITICAL THOUGHT, LEADING TO A STAGNATION OF IDEAS.**

THE CONNECTION BETWEEN LANGUAGE AND THOUGHT

ORWELL FAMOUSLY ARGUES THAT "IF THOUGHT CORRUPTS LANGUAGE, LANGUAGE CAN ALSO CORRUPT THOUGHT." THIS CYCLICAL RELATIONSHIP MEANS THAT AS LANGUAGE BECOMES LESS PRECISE, THE ABILITY OF INDIVIDUALS TO THINK CRITICALLY AND ENGAGE WITH COMPLEX IDEAS DIMINISHES. ORWELL BELIEVES THAT THE MANIPULATION OF LANGUAGE CAN CONTRIBUTE TO THE MANIPULATION OF THOUGHT AND, ULTIMATELY, SOCIETAL CONTROL.

KEY THEMES IN "POLITICS AND THE ENGLISH LANGUAGE"

COMBATting LANGUAGE DEGRADATION

TO COMBAT THE DEGRADATION OF LANGUAGE IN POLITICAL DISCOURSE, INDIVIDUALS CAN TAKE SEVERAL PROACTIVE STEPS:

PHRASE, A SCIENTIFIC WORD, OR A JARGON WORD IF YOU CAN THINK OF AN EVERYDAY ENGLISH EQUIVALENT; 6) BREAK ANY OF THESE RULES SOONER THAN SAY ANYTHING OUTRIGHT BARBAROUS.

WHY DOES ORWELL BELIEVE THAT CLEAR LANGUAGE IS ESSENTIAL FOR POLITICAL INTEGRITY?

ORWELL BELIEVES THAT CLEAR LANGUAGE IS ESSENTIAL FOR POLITICAL INTEGRITY BECAUSE IT FOSTERS HONEST COMMUNICATION AND CRITICAL THINKING. WHEN LANGUAGE IS PRECISE AND MEANINGFUL, IT ENABLES INDIVIDUALS TO ENGAGE WITH POLITICAL IDEAS CRITICALLY, RATHER THAN BEING MISLED BY OBFUSCATION.

HOW HAS 'POLITICS AND THE ENGLISH LANGUAGE' INFLUENCED MODERN POLITICAL DISCOURSE?
