- FORMATIVE AND SUMMATIVE ASSESSMENT
- INTERPRETING ASSESSMENT DATA
- DEVELOPING ASSESSMENT TOOLS AND RUBRICS
- FEEDBACK AND ITS ROLE IN STUDENT IMPROVEMENT

4. PROFESSIONAL RESPONSIBILITY

THIS FINAL SECTION EMPHASIZES THE ETHICAL AND PROFESSIONAL RESPONSIBILITIES OF EDUCATORS. TOPICS INCLUDE:

4. MANAGE TEST ANXIETY

IT'S COMMON TO FEEL ANXIOUS BEFORE A BIG EXAM. PRACTICE DEEP-BREATHING EXERCISES, POSITIVE VISUALIZATION, OR MINDFULNESS TECHNIQUES TO CALM YOUR NERVES.
