PROGRESSIVE AND GRADUATED RESPONSES

DISCIPLINARY ACTIONS SHOULD ESCALATE GRADUALLY, BEGINNING WITH LESS SEVERE INTERVENTIONS SUCH AS WARNINGS OR COUNSELING, AND ADVANCING ONLY IF MISBEHAVIOR PERSISTS. THIS APPROACH ALLOWS STUDENTS MULTIPLE OPPORTUNITIES TO IMPROVE BEFORE FACING HARSHER CONSEQUENCES.

FOCUS ON EDUCATION AND SUPPORT

THE STEPS OF PROGRESSIVE DISCIPLINE

STEP 3: PARENT/GUARDIAN INVOLVEMENT
