- HOLDING AN ACTIVE JOURNEYMAN ELECTRICIAN LICENSE IN COLORADO
- ACCUMULATING ADDITIONAL WORK EXPERIENCE (COMMONLY 4 YEARS AS A LICENSED JOURNEYMAN)
- DEMONSTRATING SUPERVISORY SKILLS AND ADVANCED KNOWLEDGE OF ELECTRICAL CODES

EXAM STRUCTURE AND CONTENT
