 - UNDERSTANDING THE PROPERTIES OF MATERIALS USED IN RESTORATIVE DENTISTRY
5. CHAIRSIDE ASSISTING TECHNIQUES
 - MASTERING TECHNIQUES FOR ASSISTING THE DENTIST DURING PROCEDURES
 - KNOWLEDGE OF PROPER INSTRUMENT TRANSFER AND MAINTENANCE

LAW AND ETHICS TOPICS

1. PATIENT CONFIDENTIALITY AND HIPAA REGULATIONS
 - UNDERSTANDING THE IMPORTANCE OF PROTECTING PATIENT INFORMATION
