9. WORKING AND PLAYING
10. EXPRESSING SEXUALITY
11. SLEEPING
12. DYING

THE MODEL ALSO EMPHASIZES THE INTERACTION BETWEEN THE INDIVIDUAL, THEIR HEALTH CONDITIONS, AND THE FACTORS THAT INFLUENCE THEIR ABILITY TO PERFORM THESE ACTIVITIES. BY FOCUSING ON THESE TWELVE ACTIVITIES, THE MODEL GUIDES NURSES IN ASSESSING PATIENTS' NEEDS AND DEVELOPING TAILORED CARE PLANS.

## ADVANTAGES OF THE ROPER LOGAN AND TIERNEY MODEL

### 1. HOLISTIC APPROACH TO PATIENT CARE

### 3. TIME-INTENSIVE PROCESS
