- HOW DO YOU SUPPORT YOUR CHILD EMOTIONALLY DURING THIS DIVORCE PROCESS?

QUESTIONS ABOUT LIVING ARRANGEMENTS AND STABILITY

THESE QUESTIONS ASSESS THE SUITABILITY OF EACH PARENT'S HOME ENVIRONMENT AND THE STABILITY THEY CAN PROVIDE.

- DESCRIBE THE LIVING CONDITIONS IN YOUR CURRENT RESIDENCE.
- HOW WILL YOUR WORK SCHEDULE AFFECT YOUR AVAILABILITY TO CARE FOR THE CHILD?
- DO YOU HAVE FAMILY OR COMMUNITY SUPPORT NEARBY?
- HAVE YOU CONSIDERED THE CHILD'S SCHOOLING AND EXTRACURRICULAR ACTIVITIES IN YOUR CUSTODY PLAN?
- ARE THERE ANY CONCERNS ABOUT THE OTHER PARENT'S LIVING SITUATION?

SAMPLE QUESTIONS ON PROPERTY AND FINANCIAL MATTERS

QUESTIONS ON ASSETS AND DEBTS

THESE INQUIRIES SEEK TO IDENTIFY ALL MARITAL ASSETS AND LIABILITIES FOR EQUITABLE DISTRIBUTION.

- WHAT ASSETS DID YOU AND YOUR SPOUSE ACQUIRE DURING THE MARRIAGE?

- ARE THERE ANY JOINT BANK ACCOUNTS OR INVESTMENTS CURRENTLY HELD?
- HAVE YOU DISCLOSED ALL DEBTS, INCLUDING CREDIT CARDS AND LOANS?
- WHO PRIMARILY MANAGED THE FINANCIAL ACCOUNTS DURING THE MARRIAGE?
- HAVE YOU MADE ANY TRANSFERS OR WITHDRAWALS FROM JOINT ACCOUNTS SINCE SEPARATION?

SAMPLE QUESTIONS REGARDING SPOUSAL SUPPORT

SPOUSAL SUPPORT, OR ALIMONY, IS A FREQUENT DISPUTE IN DIVORCE TRIALS. QUESTIONS IN THIS AREA AIM TO EVALUATE THE NEED, ABILITY TO PAY, AND FAIRNESS OF SUPPORT ARRANGEMENTS.

QUESTIONS TO ASSESS NEED FOR SUPPORT

THESE QUESTIONS FOCUS ON THE REQUESTING PARTY'S FINANCIAL SITUATION AND EARNING CAPACITY.

- WHAT IS YOUR CURRENT MONTHLY INCOME AND EXPENSES?
- DO YOU HAVE THE SKILLS OR EDUCATION TO OBTAIN EMPLOYMENT?
- HAVE YOU MADE EFFORTS TO FIND EMPLOYMENT SINCE SEPARATION?
- ARE THERE ANY HEALTH ISSUES LIMITING YOUR ABILITY TO WORK?
- WHAT FINANCIAL SUPPORT, IF ANY, HAVE YOU RECEIVED FROM YOUR SPOUSE SINCE SEPARATION?

QUESTIONS TO DETERMINE ABILITY TO PAY SUPPORT

THIS LINE OF QUESTIONING EVALUATES THE PAYING PARTY'S FINANCIAL CAPACITY TO PROVIDE SPOUSAL SUPPORT.

- WHAT IS YOUR CURRENT MONTHLY INCOME AND FINANCIAL OBLIGATIONS?
- DO YOU HAVE OTHER DEPENDENTS REQUIRING FINANCIAL SUPPORT?
- HAVE YOU EXPERIENCED ANY CHANGES IN EMPLOYMENT OR INCOME RECENTLY?
- CAN YOU PROVIDE EVIDENCE OF YOUR FINANCIAL STATUS, SUCH AS TAX RETURNS OR PAY STUBS?
- ARE THERE ANY DEBTS OR EXPENSES THAT SIGNIFICANTLY AFFECT YOUR ABILITY TO PAY SUPPORT?

QUESTIONS ADDRESSING PERSONAL CONDUCT AND ALLEGATIONS

- ARE THERE ANY WITNESSES WHO OBSERVED THESE INCIDENTS?
- HOW HAS THE ALLEGED CONDUCT AFFECTED YOUR WELLBEING AND YOUR RELATIONSHIP WITH THE CHILDREN?
- HAVE YOU SOUGHT ANY PROTECTIVE ORDERS OR COUNSELING RELATED TO THESE ALLEGATIONS?

QUESTIONS ON INFIDELITY AND MARITAL MISCONDUCT

THESE INQUIRIES EXPLORE THE IMPACT OF MARITAL MISCONDUCT ON THE MARRIAGE AND DIVORCE PROCEEDINGS.

- ARE YOU AWARE OF ANY INSTANCES WHERE YOUR SPOUSE WAS UNFAITHFUL?
- HOW DID YOU LEARN ABOUT THESE INCIDENTS?
- DID MARITAL MISCONDUCT CONTRIBUTE TO THE BREAKDOWN OF THE MARRIAGE?
- HAS THE ALLEGED MISCONDUCT AFFECTED CHILD CUSTODY OR SUPPORT CONSIDERATIONS?

TIPS FOR EFFECTIVE QUESTIONING DURING DIVORCE TRIALS

ADDITIONALLY, ANTICIPATING OPPOSING COUNSEL'S STRATEGY AND PREPARING FOR CROSS-EXAMINATION ENHANCES TRIAL READINESS. DOCUMENTING ALL RESPONSES CAREFULLY SUPPORTS CASE STRATEGY AND POST-TRIAL MOTIONS IF NECESSARY.

- PREPARE QUESTIONS TAILORED TO THE SPECIFIC ISSUES IN THE CASE.
- MAINTAIN A PROFESSIONAL TONE TO AVOID INFLAMING EMOTIONS.
- USE A LOGICAL SEQUENCE TO BUILD A COHERENT NARRATIVE.
