UNDERSTANDING THE PURPOSE OF PHILOSOPHY OF EDUCATION STATEMENTS

MOREOVER, PHILOSOPHY OF EDUCATION STATEMENTS HELP ALIGN TEACHING METHODS WITH BROADER EDUCATIONAL GOALS AND INSTITUTIONAL MISSIONS.

CLARIFYING EDUCATIONAL BELIEFS

TIPS FOR EFFECTIVE STATEMENTS

- MAINTAIN A PROFESSIONAL AND OBJECTIVE TONE THROUGHOUT THE STATEMENT.
